Membership Renewal

Procedures for membership renewal are as follows:

- 1) Subscriptions for the following year are set at the AGM.
- 2) Subscriptions are due by the end of January following the AGM at the very latest.
- 3) Renewal after the end of January following the AGM will incur an additional administration fee of £25.00.
- 4) Members wishing to fly at Broken Bank in January must have completed their membership renewal (including BMFA insurance) before they will be allowed to fly.
- 5) Renewal requires that the required fee be received by the Membership Secretary (by cheque or cash) or to have been deposited in the club's bank account by BACS transfer.
- 6) A £5.00 discount will be applied to DMAC subscriptions for all members who pay their BMFA subscriptions through the club. Members who do not choose to pay their BMFA membership this way will not be issued with a DMAC membership card until their BMFA record shows that their BMFA subscription has been paid.
- 7) Family membership is available to families living at the same address. To qualify for Family membership, one full Senior member must register as Head of Family; a spouse/partner and all children under 18 years old can then register as Family members at a reduced fee.
- 8) Members paying by cheque should write their BMFA number on the reverse.
- 9) Members paying by BACS transfer should quote their BMFA number as reference in the transaction and confirm by email to frans.cr.king@gmail.com together with a scanned copy of the completed and signed agreement on page 2.

DMARES

DMARES stands for Drone & Model Aircraft Registration and Education Scheme. This relates to a change to the law regarding the operation of model aircraft or drones (weighing more than 250g) outdoors. The scheme is administered by the CAA.

This law came into effect on the 30th November 2019 and is almost certain to apply to all members of DMAC who fly models at Broken Bank.

To comply with the law you must do two things:

1) Be able to demonstrate that you are competent to operate a model aircraft.

The CAA will accept as evidence of this, the holding of any BMFA achievement award ("A" or "B" certificate) in any discipline.

A number of our club members, although perfectly competent fliers, do not hold a BMFA achievement award. To overcome this, the BMFA have developed a simple 10 question quiz which can be completed through the membership portal https://rcc/bmfa.uk/

With immediate effect you MUST hold either a BMFA achievement award or have completed the BMFA quiz in order to be allowed to fly at Broken Bank.

2) Register as an "Operator" with the CAA and pay a £9.00 registration fee.

The BMFA have obtained an exemption from this registration requirement for members renewing their membership for 2020 and paying the £9.00 fee to the BMFA. They will then register you with the CAA using the information from your membership record.

Once registered, the CAA will issue you with an "Operator ID" which must be displayed on every model. The CAA will send you your operator ID number by e-mail in February. There is no requirement for BMFA members to display their operator ID on their aircraft until 23rd February 2020 at the latest.

For this registration method to work, it is vital that your membership records are complete and correct.

We are asking all members to complete and return the simple check form below as part of their membership renewal. The form must be signed and dated in order to give us the authority to collect and hold this personal information and share it with the BMFA and the CAA. (This is to comply with GDPR regulations).
